## WAIVER AND RELEASE AGREEMENT

**This is a release of liability and waiver of certain legal rights.**

I/We hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS the Jamestown Community Fair Association, its directors, officers, agents and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation of this activity including, but not limited to NEGLIGENCE of any kind or nature, whether foreseen or unforeseen.

Exhibitor/Participant assumes entire responsibility and hereby agrees to protect, indemnify, defend and hold the Jamestown Community Fair Association harmless against all claims, losses and damage to persons or property, governmental charges or fines and attorneys' fee arising out of or caused by exhibitor's/participant's installation, removal, maintenance, etc.
